1. Apologies. None

2. Minutes of the last meeting and actions arising.

Minutes of the meeting 19th May 2022 were approved and signed at the meeting.

Action: WJ to put onto website.

3. Matters Arising

NTD reported that he visited the Calcot property and was happy that works being carried out there were not subject to planning consent. 20 is plenty Speed limit surveys and research into defibrillators will be done in near future.

Action: NTD – 20 is plenty traffic survey and research into Defibrillators.

4. Cotswold Neighbourhood Team (CNT) Inspector – Simon Ellson

Simon reported to the meeting how the CNT works in the area. Simon reported that crime in the Valley is low compared to other areas in the county but residents still needed to be vigilant in the area and take responsibilities for their property to be secure. A new PC has been employed for the Lechlade & Fairford area and is due to start soon. Simon welcomed residents to contact him via the website/Andy Pease or in more urgent cases phone 999/101.

NTD thanked Simon for attending the meeting. Simon then left and the meeting continued.

5. Financial Report – Accounts to date.

The Councillors had all received a copy of the accounts with their meeting papers. NTD explained that spending this year was higher than the precept 2022/23 received so this needs to be reviewed at the next meeting ready for the new financial year 2023/24.

6. Funding Contribution to Calcot Parking Project.

NTD explained that the parking was not the responsibility of the Parish Council however at previous meetings the Councillors had agreed that they would help with the discussions between the residents of Calcot. Calcot residents had received a quote from Houston Construction with groundworks that would help to solve the problem, particularly in the

winter, quote attached to minutes. Jonathan explained to the meeting the quote. Residents agreed that they would arrange a meeting to discuss the way forward as these works to be done were not agreed by all the residents. NTD informed that the works would need to be agreed also with Highways if they were to go ahead. The councillors decided that if the residents came back to the Parish Council with a resident approved project, then they would discuss/consider a contribution towards the works but significant funding for the project would have to come from the residents of Calcot.


7. Planning Applications Received. NTD left the meeting and Malcolm (MC) chaired the meeting for the last two items on the agenda.
