MINUTES OF THE MEETING

1. Apologies had been received from Anthony Thorp who was on holiday

2. Update on Mobile Phone Coverage - HTR summarised meeting with Atlas (a private telecoms infrastructure provider). In brief:

- There is limited mobile coverage across the valley
- Atlas can put up a mast to resolve this but position to be confirmed and with agreement from the community
- All agreed mobile coverage is a problem that needs to be resolved and to be taken forward.

Action:

- *HTR to send mast option maps to NTD and councillors*
- *HTR to ask Atlas to mock up a visual of the mast with dimensions*
- *Council to plan and publicise an open meeting with Atlas and members of the community once mock ups are ready*

3. Minutes of the meeting held on 19th June 2025 at 6.30pm were approved.

- Raves are under control
- David Fowles reminded to look into the unknown £215.48 payment
- Assessment of Coln St Dennis tree was cancelled as it didn't look dangerous
